Expert" The goal of the Training Toolkit is to define,
organise, implement and evaluate all necessary actions
for developing a new training program in order to
meet the training needs of the new occupation and
qualification. There were discussed the framework of
the modules which will be posted on a Digital Training
platform in order to offer access to any learner to study
by her/himself the uploaded materials.

There discussed the following module:

- Sustainability Management-presented by RTU
- Environmental Performance- presented by RTU
- Corporate Social Responsibility-presented by TUIASI
- Circular Economy-presented by TUIASI

During the meeting, the framework and the content of the learning materials were carefully analysed and discussed. The final stage of all these materials will be posted on the Digital Platform of the Project. All the participants agreed on the idea that learning materials must be understandable, easy to access, download and study for any learner who has to self-training and gain new competencies, skills and knowledge. Despite the multidisciplinary nature of the Training Units, it will still allow each user to select the specific area or field wishes to focus on most.
